ABSTRAK

Penelitian ini difokuskan pada dua rumusan masalah yaitu apa faktor penyebab terjadinya pernikahan dini di masa pandemi covid-19 di Desa Takisung, Kecamatan Takisung, Kabupaten tanah Laut, bagaimana dampak pernikahan dini di masa pandemi covid-19 di Desa Takisung, Kecamatan Takisung, Kabupaten Tanah Laut.

Penelitian ini merupakan penelitian empiris. Lokasi penelitian di Desa Takisung, Kecamatan Takisung, Kabupaten Tanah Laut. Jenis dan sumber data dari data primer yang diperoleh dilapangan dan data sekunder dari kepustakaan, perundang-undangan dan objek penelitian terkait. Pengumpulan data menggunakan teknik wawancara, observasi dan dokumentasi. Data yang diperoleh dari teknik tersebut kemudian dianalisis dan dipaparkan dalam bentuk kata-kata.

Hasil penelitian menunjukkan bahwa pernikahan dini di Desa Takisung rata-rata disebabkan karena faktor ekonomi. Faktor pendidikan juga mempengaruhi pernikahan dini karena, ekonomi yang rendah sering kali berpengaruh terhadap proses pendidikan sehingga mengakibatkan pekerja dibawah umur. Selain itu, faktor adat setempat yang meyakini jika anak perempuan lambat menikah akan menjadi perbincangan. Adapun dampak yang dirasakan pelaku pernikahan dini rata-rata berdampak pada ekonomi dan psikologis. Selain dampak negatif, terdapat pula dampak positif dari pernikahan dini yakni secara psikologi membuat pelaku pernikahan dini lebih dewasa.

This research focuses on two problem formulations, namely what are the factors that cause early marriage during the covid-19 pandemic in Takisung Village, Takisung District, Tanah Laut Regency, how is the impact of early marriage during the COVID-19 pandemic in Takisung Village, Takisung District, Tanah Laut Regency.

This research is an empirical research. The research location is in Takisung Village, Takisung District, Tanah Laut Regency. Types and sources of data from primary data obtained in the field and secondary data from literature, legislation and related research objects. Collecting data using interview, observation and documentation techniques. The data obtained from these techniques are then analyzed and presented in the form of words.

According to the results of the study, it was shown that early marriage in Takisung Village was mostly caused by economic factors. Educational factors also affect early marriage because a low economy often affects the education process, resulting in underage workers. In addition, the local custom factor which believes that girls are late in marriage will become a topic of discussion. The impact felt by the perpetrators of early marriage on average has an economic and psychological impact. In addition to the negative impacts, there are also positive impacts of early marriage, namely psychologically making the perpetrators of early marriage more mature.
