ABSTRACT

Cycle time is the time required to complete an operating cycle. This study focuses on the computer hard disk production in a studied company. The study includes the research of cycle time for each process in blanking. The time involved in quantifying the cycle time is the waiting time, processing time, maintenance time, and inspection time. After all, values were recorded for the relevant time; the cycle time value obtained was 74.02 sec. The reading was based on values recorded in the original layout at the studied industry factory. To fulfill the objectives of this study, a systematic layout planning (SLP) approach was performed to obtain a shorter total cycle time. The layout of plants affects the cycle time involved in producing a product. This study continues to examine the layout of the existing system in the production department, analyzing the production layout systems, propose a new production layout, and using Arena software to assess the new layout. Arena software is a modern approach to solve the layout problem without making physical changes to the original layout, but only use the simulation to shows its effectiveness. Indirectly, the Arena software consumer can find the time, output, cost, and utilization in the production workflow. In this study, the Arena software approach is successfully proved that the cycle time taken for alternative layout 2 is shorter than the original layout where 48.85 sec for alternative layout compares to 74.02 sec for the original layout. The total output in the alternative layout also showing a great increase which is 1080,000 pieces hard disk per month compared to 720,000 pieces hard disk per month in the original layout. Therefore, the second alternative layout was chosen as the new layout in this study to reduce the cycle time in the hard disk production line.

CHAPTER I

INTRODUCTION

1.1 Study Background

More than 40 countries with multinational companies such as United States, Australia, Belgium, and Denmark have invested in over many projects in Indonesia's manufacturing sectors. This is because Indonesia's attractive environment, and this has proven that the country can become one of the world's leading locations for offshore manufacturing activities.

All organizations have their own goals and objectives. It can be said that all business organizations have the same goal to maximize their investment. Among the factors that need to be emphasized in the industry other than productivity, quality, job scheduling, job review, ergonomics, and facility planning is the cycle time needed to produce a product.

Cycle time is the sum of the processing time for each step taken to complete a product. The efficiency of the production process depends on time study. Standard time is a modern technique for motion studies that study the same motion and times. Reducing cycle time will ensure more efficient production and increased productivity. Cycle time is the total amount of time from start to finish as determined by the company and the customer. Cycle time consists of the processing time, from the start of the raw material receipt, and the time taken this raw material goes through several other processes before it is fully completed.

Reducing cycle time can speed up the production and delivery of products to customers faster and at a lower cost. In other words, the management of processing order within a company plays an important role and provides long-term benefits to the company.

There are a few things to consider in a factory setting such as production and flow processes, material handling methods, equipment requirements, growth plans, capacity planning, and management. The design and arrangement of machinery or machines are important because they optimize efficiency and also help workers to handle work in a controlled, fast, and comfortable manner. The main objective of the factory layout is to make the product production process run more smoothly, systematically, and to reduce processing time.

This study focuses on the usefulness of cycle time study as it plays an important role in the production of a product. Cycle time is divided into several categories:

- Manual cycle time. Comprising of manual processing time such as unloading, installing man-made without a machineassisted machine.
- b. Cycle time. Time is taken by a machine during operation.
- c. Automatic cycle time. Time is taken by machine without must be set up by the operator.
- d. Overall cycle time. The total time is taken to produce one unit. Often this type of cycle is studied for a machine or process only.

e. Total cycle time. This includes the total time for a single product to be completed. This takes into account the process by machine or manual from start to finish.

1.2 Problem Statement

It is difficult for an engineer to evaluate the speed of operation of a machine and at the same time reduce the scaling and keep the production level in good condition. Thus, simulation applications from ARENA will help analyze any improvement activities needed in the production process. The simulation model will present data on time and product performance that are difficult to calculate manually. The data from the simulation will be used in two different interests namely productivity improvement and process utilization. In enhancing the company's productivity, this study will present data to reduce cycle time. This study can suggest an effective production that will increase the value of the product through each input entity and also to suggest a better process planning.

1.3 Objectives of Study

- a. To study the cycle time of production hard disk computer.
- b. To study and understand the flow of each process in the production of hard disk computer.
- c. To make evaluation based on both systematic layout planning (SLP) and simulation of layout using ARENA software (student version).

1.4 Scope of Study

- Identify and analyze processes and other aspects of production hard disk computer.
- Study, create and simulate models using ARENA software. At the end of the simulation, the results will be compared between all layouts based on output and cycle time.
- Time data is taken using a stopwatch.

1.5 Importance and Significance of Study

In today's competitive market, manufacturing excellence is critical to achieving success. This study aims to study key elements of the manufacturing strategy, the ability to compete over time, and to find the key steps in the development of the strategy. The short cycle time can be described as high customer satisfaction over the timely service provided by a production company. The importance of the study cycle time are:

- a) Study of time can help the plant to reduce the cycle time taken for the production of a product.
- b) Productivity in a plant can be increased if further research is done to reduce the processing time.
- c) Study cycle time can increase profitability to a certain company.
- d) Customers are more satisfied because of faster product development time.

1.6 Expected Results

From the data obtained, this study is expected to reduce the cycle time of each process and increase company productivity. The

data obtained will be used and applied as a suggestion to the studied industry to improve its company. From this study, it is hoped that the plant will be better to be understood and emphasize the systematic layout to reduce cycle time while increasing the company's output.

1.7 Conclusion

This chapter discusses the introduction of the study including the background of the study, the problem statement, the objective of the study, the scope of the study, the importance and anticipation of the results of the study to be undertaken. Studies on the cycle time are made and factors that influence the time taken will be identified before any improvements can be made to shorten the cycle. The systematic layout planning (SLP) approach will be used as one way to shorten the cycle time in production.

In the next chapter, it will discuss previous studies related to this conducted study. There are a few things to discuss to help this study to achieve its main objectives.

CHAPTER II

LITERATURE STUDIES

3.1 Introduction

To understand this study in more detail, the literature review plays an important role in seeking out previous sources related to the subject of this study. This whole chapter deals with topics such as cycle time, motion study, cycle time reduction, layout planning, types of layouts, layout issues, SLP approaches, sequences Muther's SLP, quality function usage, and also ARENA software.

3.2 Cycle Time

Cycle time according to Q-Finance, that is a firm of financial resources, is defined as "the period required to complete one cycle of operation, or completing an event, business, or service. Cycle time is used to distinguish the entire time of a process from the time of its production.

According to PCMag Encyclopedia, cycle time refers to the time taken to produce a product to market from the beginning of the process to the end of production. Cycle time includes processing time, moving time, wait time, and check the time. Time category can be defined as follows:

- 1. Processing: the time taken to complete the process without any additional work.
- Waiting: the time is taken to wait for another process to take place.
- 3. Moving: the time taken for shipment work.
- 4. Customization: the time it takes to do any modification.

5. Checking: the time taken to perform inspections or tests to work.

3.3 Review Motion(Motion Study)

Movement and study time help management determine what products are produced by workers in a specific period. Therefore, it is easier to predict the work schedule and output of production. Motion and Time Study is a scientific method designed by two individuals for the same purpose of increasing productivity and reducing unit costs. Frank B. Gilbreth has created a *motion study* to determine the best path for a complete job. Frederick W Taylor has conducted a time study in which he measures how much time a worker takes for a full-time job.

Frank and Lillian Gilbreth have used camera footage to see how the work moves in preparation for a process. This makes it easier for them to make improvements to these processes. Time and motion studies have been used separately in the past, but at the moment, both are necessary because they have a strong connection.

Frank B Gilbreth introduced his ideas in the study of movement through bricklaying in his work in 1885. He began to observe the workings of bricklaying workers by recording them. After the brick was laid, he noticed that workers began to examine the brick to see if it was compatible with other bricks. He later suggested that the workers make a classification of the bricks first before the excavation works. With this method, the time required to settle is shorter.

Frederick W. Taylor used a stopwatch and a piece of a clipboard to record the time of his study. She began her research

with her own family by recording the time they spent completing activities around the house.

According to Frederick W.Taylor, the study of time using the stopwatch is the most common technique for standard production time in manufacturing. Timing standards are the most important element for obtaining manufacturing information, and the use of stopwatch time is the only way that management and employees agree. The study of the stopwatch was developed in the 1880s and was the first technique used to set the standard time.

Manufacturing companies have found that they can use time and motion research to grow their business in a variety of ways. The manufacturing industry uses motion and time studies to reduce wasted time and improve time for one complete task. Today, every business such as manufacturing, the warehouse also emphasizes motion and time study methods to reduce costs and help achieve their sales goals.

Using a stopwatch in the study of motion and time study is the most effective method in studying any time for a process in the industrial field. In this study to identify the cycle time, two types of stopwatch will be used namely continuous stopwatch and snapback stopwatch.

a) Continuous stopwatch.

A continuous stopwatch is used for recording time continuously. This method will be used to derive the operating time value of a machine. The use of continuous stopwatch allows time to be taken continuously from start to finish.

b) Snapback stopwatch.

Snapback stopwatch ideally is used to get repeated readings on a single process. The principle of this snapback stopwatch is that the readings are returned to zero value that means the second readings are ready to be taken. The use of a snapback stopwatch is easier than a continuous stopwatch as it is easier and faster to record time.

3.4 Cycle Time Reduction

Philips Thomas states that, according to his study, by reducing cycle time, the quality of a mill will increase. Rapid production allows for low inventory levels, as well as exposing weaknesses and increasing rates of change. After eliminating all unnecessary values or steps, defects in the production process can be minimized. The fast and fast process allows for a continuous supply chain. Besides, customers will also trust the manufacturing company as well as strengthen business relationships.

According to Philips, cycle time is the time required to complete a process. The cycle time may start with a phone call from the customer, followed by the request process and ending with an order including delivery to the customer. A complete process has many smaller processes under it such as ordering, assembly, inspection, packing, and shipping. Cycle time is the cumulative time of the processes in the production operation.

Reducing cycle time focuses on implementing effective methods to shorten the time. Reducing cycle time requires the elimination of any activity or work that does not bring any benefits or does not play a significant role in the final product. Examples of such activities include damage repair time, machine maintenance, prolonged inspection, testing, and schedule overlap.

One study was conducted to determine the reduction of cycle time in the production process *mold*. While the production process has many interesting features, there is one obstacle to its growth in the industry. The downside is that the cycle time is too long for the production process. The cycle time for these problems includes the time taken for heating and cooling processes. The study was conducted by several researhers, including MZ Abdullah, S. Bickerton, Crowford, and Bhattcharyya.

Abdullah has experimented with reducing the cycle time of the casting process by adding nail polish (28% reduction) or roughness elements (18% reduction) to the outer surface of a mold. Other experiments that have been carried out include internal pressure, internal cooling, and water spray cooling.

Significant reductions in overall cycle time have been observed. Although the dominant factor in these comparisons is to leave an impression, it is difficult to quantify because these comparisons involve interactions between the two techniques (surface-enhanced molding and inner impact pressure). However, this combination should be considered by the industry as it offers a significant reduction in cycle time and significant improvements in the mechanical properties of the final product.

Based on the statement from Philips Thomas and the study from MZ Abdullah, it is well known that the importance of reducing cycle time can guarantee success in industry and manufacturing. Most customers urge manufacturers to move faster and at the same time the quality of the product should be improved to meet their needs. Through this study, the company should focus on ways that it can reduce the cycle time.

Reducing cycle time is a good starting point for improving production operations as it does not require significant capital investment. On the other hand, the length of the cycle will result in the high of stock quantity, requiring high maintenance costs but less customer satisfaction.

Customers generally evaluate a supplier's performance on four factors: product performance (features), price, quality, and delivery within a reasonable time frame. Overall, reducing cycle time has several distinct advantages such as:

- i- Customer demand for products to be completed in a short time.
- ii- Increase productivity.
- iii- Reduce manufacturing process.
- iv- Reduce production costs.

3.5 Management and Reducing Cycle Time

In the 1950s two prominent Americans, Edwards Deming and Joseph Juran, introduced the techniques of advanced quality control for the Japanese while Japan rebuilt its empire. Over the next 20 years, the Japanese community can improve its quality by practicing management and reducing cycle time. In the 1970s, the quality of Japan's products was at its highest, and Japan easily acquired important stocks in the western market.

Managing and reducing cycle time can reduce the amount of time required for all activities involved including ordering, design, supply management, production, and more. Managing and reducing cycle time has two goals to achieve:

- i. Improve the cost and quality of the product. The reduction of cycle time is very suitable to be studied for activities in progress. This is because it allows non-essential activities to be removed from the production process. With this, the product development process becomes shorter. The quality of the product can also be improved because the existing time is focused to be used to the essential processes only.
- ii. Finding real-time for each activity. Reducing cycle time helps management find the exact time each process requires. Once a

deduction for unnecessary activity is performed, the time allocated for that activity can be determined.

The study of cycle time at the studied industry will focus more on the problems that directly and indirectly impact the cycle time of each production process. Subsequently, solutions to these problems will be proposed to reduce cycle time.

3.6 Quick Response

Michael Donovan states, "Many companies have problems delivering products at the right time, and most companies take too long to do so. This is because there is a lot of waiting time in the production process."

The waiting times are waiting for processing instructions, waiting for raw materials, waiting for process maintenance, and more. This waiting period will increase inventory, increase costs, and cause customers to lose confidence in the company.

The adverse effects of long wait times are very broad and can affect the productivity of a company. The wait-time problems in the production process are as follows:

- Poor delivery system. Due to the poor delivery system, it makes customers unhappy with the way they manage their company. Delivery on time and customer satisfaction should be taken into consideration. Too long a cycle can cause customers to lose trust and companies are more likely to suffer losses if customers withdraw and choose to deal with other companies.
- 2) Business is too complicated. In doing business, the process of handling sales, receipt of materials, production schedule,

and any other activities should not be handled in such a complicated way as it will only prolong the cycle. Management should be carried out in an orderly way to reduce the cycle time and processing costs of a product.

- 3) Bottlenecks. Bottlenecks occur when there are some problems with the production process. For example in the workflow, each process is related to each other. If there is a problem with one process, it will disrupt the next process. This will cause bottlenecks and cause the workflow to go down smoothly. The problem of bottlenecks will result in wasted time and indirectly, the cycle time taken by the process is longer.
- 4) Too much extra activity. Examples of additional activities include the relocation of raw materials and renovations to production areas. This activity will only prolong the cycle and delay the production process and the longer the wait time. When the activity of producing a product takes too long, this means that the product delivery to the customer must also be postponed.
- 5) Low-quality level. When the quality of the product produced does not satisfy the customer, so the product will be returned to the factory. The company has to review the product to satisfy the customer. These events can be avoided if each product is given enough attention before it is sent to the customer. When this happens, more time and costs are required to conduct a second check. Good quality should be maintained to give customers the confidence to continue to do business with the company.

3.7 Layout Facilities

Machine layouts, storage areas of the work area, and office usually have limited space according to the firm's space capacity (Henry 2003). A plan is intended for determining and organizing requirements such as machines and other equipment within a space. It allows for a smooth flow from the raw material input, the production process, to the final process with low cost and limited oversight and control. (Richard Multer.1973)

3.8 Layout Problems

Problems with layout have been identified for the past few decades (Meller and Gau, 1996). However, most research approaches to layout in the manufacturing system are incomplete and are not well used in solving layout problems effectively. Effective layouts play a very important role in the manufacturing process (Canen and Williamson, 1996). The layout is designed based on the importance and achievements that the industry wants to achieve (Allegri 1984, Tompkins et al.2003). Many technologies such as algorithms, computer simulation (Azadivar and Wang, 2000), fuzzy logic theory (Cheng and Gen, 1996), dynamic programming (Rosenblatt, 1986) have been developed. The purpose of all these technologies is to help their companies find more effective procedures.

Algorithmic approaches are commonly used to simplify design problems as well as to achieve goals and serve as a practical solution (Peters and Yang 1997; Cardarelli and Pelagagge 1995, Geiger 1997). This approach usually involves only quantitative input data. While the output of the algorithmic approach is often needed to make future improvements according to design requirements such as the shape of each part, supply facility, material maintenance system, ergonomics, storage works, demand space, etc. (Yang, Taho Su, Chao-Ton, Hsu, Yuan-Ru, 2000).

In a procedural approach, Muther (1973) introduced a systematic layout planning (SLP) method which not only used to create new layouts for tools but also became a guide for the design and widely used by all organizations (Yang 2000). SLP is known around the world as a way to build layouts. Thousands of projects are all successful using the SLP approach. This study uses Muther's approach in systematic layout planning to solve layout problems in hard disk production. ARENA software will be used to evaluate design alternatives. There are three sections in this study that involve SLP. The first is to describe the work for SLP, the second is to describe the actual situation in the plant using the SLP workflow and ARENA software, and the third is the preparation of conclusions and discussion of future research needs.

3.9 Factors Affecting Layout

According to Henry (2003), the factors that influence layout design are as follows:

- i. Volume and weight of goods to be produced.
- ii. Properties of services provided.
- iii. Cost of area or building for product development.
- iv. The facilities provided for the product.
- v. Product or component weaknesses.

3.10 Advantages of Good Layouts

Henry (2003) presented his study result and concluded that good layouts bring many advantages to companies to enhance production activities such as:

- i. Reducing *bottlenecks* in the movement of employees or products.
- ii. Reduce material handling costs.
- iii. Reduces harm to individuals.
- iv. Employee utilzation is more effective.
- v. Create a working spirit.
- vi. Effective use of space.
- vii. More flexible.
- viii. Facilitate supervision.

3.11 Types of Layouts

Evans (1997) in his book '*Production & Operation Management: Quality, Performance, and Value*' states the layout plan is divided into four categories:

- i. Layout process.
- ii. Product.
- iii. Cellular (Group Technology).
- iv. Layout fixed-position.

2.11.1 Process layout

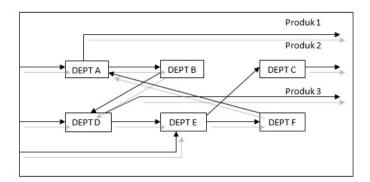


Figure 2.3. Process layout (Source: James R.Evans.1997)

Process layouts are the standard layout used in the production process to streamline workflows. Figure 2.3 shows an example of a process layout.

2.11.2 Product layout

These layouts are used to handle multiple processes and link to each other.

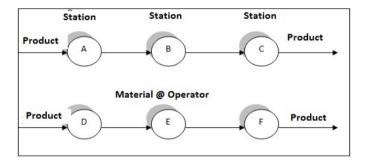


Figure 2.4. Product layout (Source: James R.Evans, 1997)

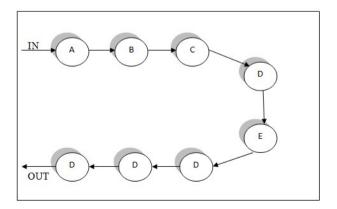


Figure 2.5.Product layout/U-Shape (Source: JR. Evans, 1997)

3.12 Systematic Layout Planning (SLP)

SLP is a technique developed by Richard Muther *et al.* There are three basic areas involved in this technique: Connection, Space, and Control.This technique enables users to identify, observe, and evaluate the various types of activities, relationships, and solutions involved in project layouts (Muther 1973).

There are fourteen objectives in the design layouts using SLP approach, namely:

- Provide sufficient space in the production of material
- Reduces maintenance costs
- Reduces movement of workers and also to reduce the danger to the workers
- The effective use of workers
- Boost employee morale
- Use more effective space
- Reducing accidents
- Facilitating maintenance work
- Simplifying coordination and communication
- Prioritizing worker safety and health
- Increasing machine
- Productivity

According to Evans (1997), there are several advantages and disadvantages of using SLP as one of the methods to solve the layout problem. Among the advantages are:

- It is a clear and logical technique for layout.
- It can determine the importance of the relationship between one side and the other.
- Controlled through the concept of *trial and error*

• The process will be more flexible

Among the disadvantages are it requires many individuals skilled in handling, and also it is difficult for production planning and control.

According to Richard Muther (1973), Systematic Layout Planning (SLP) involves eleven sequences starting with step 1(input data and activities), step 2(flow of materials), step 3 (activity relationships), step 4 (relationship diagram), step 5 (space requirements), step 6 (space available), step 7 (space relationship diagram), step 8 (modifying considerations), step 9(practical limitations), step 10 (develop layout alternatives), and step 11 (evaluation).

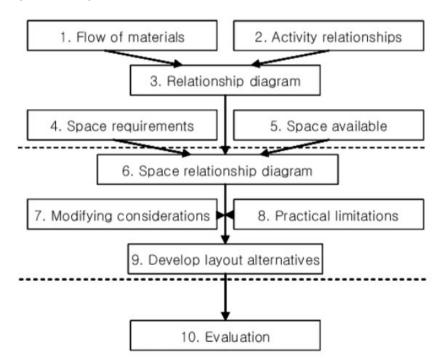


Figure 2.6. Eleven steps Muther's Systematic Layout Planning

3.13 ARENA Software

According to Uttapol Smutkupt (2009), ARENA software is a combination of high-level software used to simulate and analyze the effects of changes that involves to redesign related to supply chain, manufacturing, process, logistic, distribution, and warehousing, as well as service systems. ARENA software is flexible and widely used in applications that include very detailed and complex models (ARENA Simulation, 2009).

Some of the scenarios involved in the use of Arena software include:

- Detailed analysis of all types of production systems including material and component management.
- Analyze customer service and customer management systems.
- Comprehensively analyze the supply chain including warehousing, transportation, and logistic systems.
- Predict system performance based on metrics such as cost, cycle time, and usability.
- Identify the causes of bottlenecks such as delays at a station as well as the excessive use of available resources.
- Designing workers, tools, or essential goods.

3.14 Conclusion

This chapter discusses literature relating to this study such as discussion about cycle time, time category definition, motion study, cycle time reduction, time management, layout facilities, layout issues, layout advantages, and disadvantages and use of Arena software. The next chapter discusses the methods or techniques that will be used to make this study successful conducted.

CHAPTER III

METHODS OF STUDY

3.1 Introduction

In this chapter, several methods will be discussed to conduct cycle time study in the studied company. These methods will be used to collect and analyze data related to the company production time. The layout study is one of the problems that may affect the production cycle time. Solutions to the layout will reduce cycle time and increase efficiency and productivity at this company. It is important to understand the workflow and processes involved in the company. All of these methods play an important role in the success of this study.

3.2 Research Methods

It is important to use any certain methods to collect and then analyze the collected data. There are two methods used in this study which are observation methods, and SLP approach followed by the application of ARENA software.

The use of stopwatch is a direct observation method. The use of a stopwatch is the most suitable method to obtain time readings. Each work process will be recorded using the stopwatch, and the time value can then be rewritten in the work schedule more easily. The use of the stopwatch in this study used two different types of clock, namely continuous stopwatch and snapback stopwatch. Some of the key steps in this method are:

i- Identifying each process to be studied.

- ii- Determines how often the readings are taken as well as the quantity of samples to be studied.
- iii-Take readings using a stopwatch and record the data in the form.
- iv-Calculating the average real-time. The actual average cycle time is the total amount of time per read per sample.

The second method is an approach named as systematic layout planning (SLP) functioning to create new layouts in production. The proposal to create a new layout is to improve the original layout problems in the company, because the layout will affect the cycle time in production hard disk. Two alternative layouts will be featured in this study. On the other hand, the use of Arena software is to simulate the new layouts resulted from the using of SLP method.

3.3 Workflow

In the workflow to complete this study, the implementation phase is divided into two phases namely the implementation of the first phase and the implementation of the second phase. The first phase involves a literature review, identifying the plant according to the relevance of the study, making a rough assessment of the entire plant to be studied, gathering information and data, and identifying the problems faced by the plant that affect the cycle time of each process.

While the implementation of the second phase of work involves the extension of the first phase of analyzing problems and identifying the causes of problems, generating solutions and recommending them to the plant and preparing final reports for this study. The flowchart below shows the workflow or steps that will be conducted to be as a guide in this study.

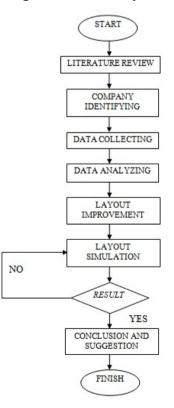


Figure 3.1. Flowchart methodology

3.3.1 Literature review

Literature Review is a composed of journal, website, and also books used in this study. The literature review covers the background of topics, theories, issues and even the history of past studies related to cycle time. Library studies are not only focused on the cycle, but they are also related to the layout of an organization and its impact on the company's production level.

3.3.2 Identifying the factory

It is important to identify the appropriate plant and to comply with the topic of study to be undertaken. This is because, after several factories visited, the studied industry plant complies with the scope of the study as well as the state of the plant in terms of the process of producing its products to facilitate the study. Through this observation, many of the reforms are possible in the studied industry but are still limited by the consent of its management.

3.3.3 Data collection

The next step is to collect data relating to cycle time. The method of collecting data is to use a stopwatch to record the time of each related process and record it in a table format.

3.3.4 Analyzing data

In this study, the SLP system is used as a research method to analyze the layout problems in production *hard disk*. The following steps are required in the SLP application to find information before simulating the SLP result by using ARENA software.

3.3.4.1 Build relationship chart

In a first step, it is important to find a correlation between activity, area, function or design of the buildings involved in the layout based on the requirements of the position (A, E, I, O, U, X).

- Identify each activity and list all activities in the contact chart.
- Determine the relationship or level of need of each activity to other activities. (A- Very useful, E- Very important, I-Important, O- Normal, U- Not important, X- Not relevant).
- In using a graph, it is necessary to follow the grid flow. For example, if a comparison is made between the first activity and the third activity, then the correlation between the first and third activities should be made so that it is shaped like a diamond which is the intersection between the two activities.
- Diamond cells are separated by a line. Use a diamond cell separator to record the connections at the appropriate level. The choice of connectivity can be determined by the user himself such as security, material flow and even the use of tools.

3.3.4.2 Building the Required Space

In this second step, the space, requirements and obstacles or distances required will be recorded for each activity. What to do is:

- Name the type of activity involved
- Identify the space required for each activity

• Identify the boundaries by importance (A, E, I, O, U, X)

3.3.4.3 Building a Relationship Diagram

Third level is to find the relationship between the needs of each activity. The AEIOUX correlation scale is as follows:

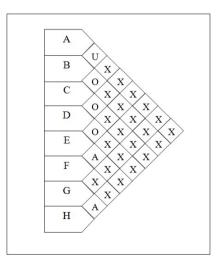


Figure 3.3. REL chart

3.4 Layout Interpretation Using ARENA

The Arena Software is an invention used to analyze the changes effects between supply chain, manufacturing systems, processes, logistics, distribution and storage and service systems.

3.4.1 Startup layout

Starting Arena by clicking *Windows start* menu, and then go to Program > Rockwell > Software > Arena. The Arena model will be displayed with the new model as shown below.

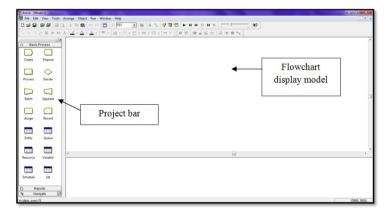


Figure 3.4. Arena view

To model the Arena, there are three parts to the application window:

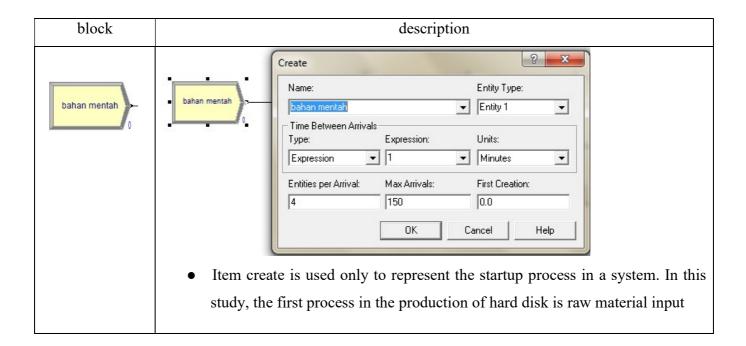
- a) Process Basics: contains various forms of process to be modeled, called modules.
- b) Report Panel: contains appropriate reports to be displayed after the simulation is run.

c) Navigate Panel: allows the user to display model views, including model directions through sub model hierarchy and to allow models to be displayed inform thumbnail.

3.4.2 Model description

The idea to develop a model is a very simple effort and no need to many efforts to develop it. This development begins by identifying the basic functions of each process in the *project bar* such as icon to *create, process, decide and dispose.* Then all of these functions will be built into a single process stream representing real processes in the industry. Unfortunately, this Arena software does not provide the accuracy of solving a product in the form of U. Besides, the model can be played in animated form to make it more attractive. The model will then be simulated to check the function, suitability and validity of the model rules. In the final stage, the selection of the process is possible based on the best possible layout solution. Table 3.1 shows a description of each process flow involved in developing the model for this study.

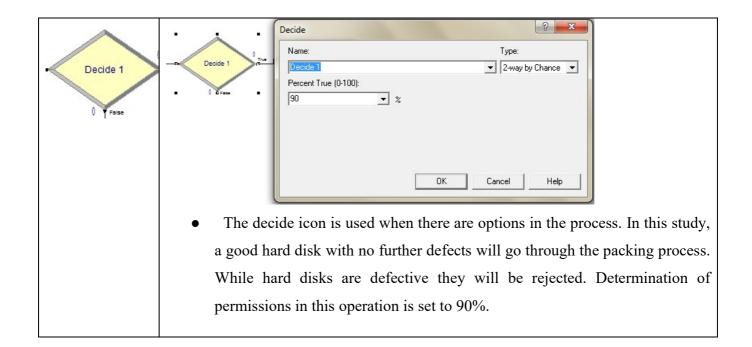

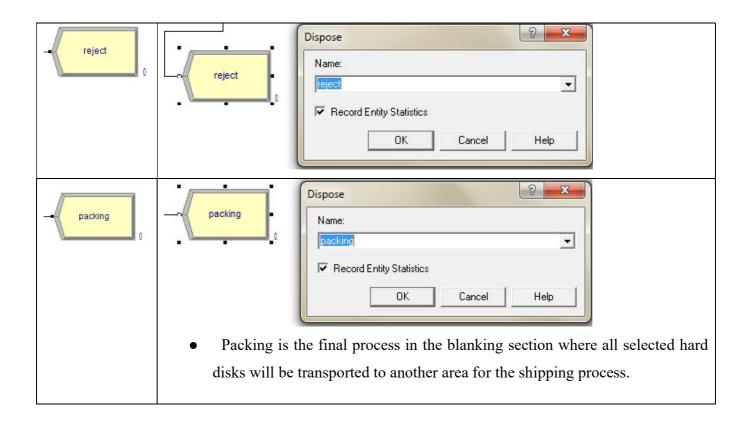

3.5 Conclusion

This chapter discusses the methods used to conduct the objective of study as informed on Chapter 1. This step is important in this cycle time study in relation to determine the data of proposed layout from each developed layout. By using the collected data, analyzing process by using Arena software will be continually conducted to evaluate each developed layout. The use of Arena software allows evaluation of the original layout, layout alternatives and the other simulation outputs.

CHAPTER IV

RESULTS AND DISCUSSION

4.1 Introduction

In this chapter, all the gathered data will be analyzed in detail. Each analysis plays an important role in ensuring that the objectives of this study are achieved successfully. To obtain time for each process, a manual method was performed using the stopwatch and the time would be recorded in the table provided. For factory layout analysis, the use of Arena software will suggest a good layout option in terms of both process cycle time and production throughput.

4.2 Observation Results

Based on observations on the studied company, it appears that production operators are working in a less systematic machine layout. Initially, the owner of the company did not consider any systematic method for machine layout in production. The effects of an unsystematic layout can actually be a huge loss to a company because there is a waste of time it takes to produce a product. Saving time will bring double benefits to the company as more output can be produced in less time. In addition, it can be noted that there are some disadvantages to the ineffectively factory layout because of a severe work environment, cross line, time wasting, and bottle neck which all of these will affect the company's output. In addition, the operator also has to take more time to ship the hard disk pieces from one part to the other. The obvious problem is in the packaging area where the bottleneck happened during waiting the operator bring finished products to the packaging area.

4.2.1. Process flow

In this study, the first step is to identify each involved process in production *hard disk* computer. Each process flow needs to be understood to facilitate the classification of the types of time involved in a process such as waiting time, processing time, check-in time and even time. Table 4.1 below describes each process involved in this study which is limited to the production area only.

4.2.2. Process time

Each process has different timings depending on the way it operates and the distance the area connects it from one section to another. Cycle time calculation includes waiting time, processing time, check-in time and maintenance time. Table 4.2 shows the time taken for each involved process to produce *hard disk*. The time was recorded using the stopwatch and the values below were averaged for each of the three readings.

In performing analysis using Arena software, there is an space *expression* in the unit time will represent the proximity of one area to another. In this study, the value difference in the space *expression* will be entered into the Arena software based on the layout that was performed. Table 4.3 below shows the expression differences between the original layout and the new layout.

4.3 Systematic Layout Planning

Involved area to produce hard disk in this study is in the *blanking* area. The hard disk production in this area is slow because the existing layout is less systematic. Plans have been made to enhance and expand production capacity through the creation of new designs. Arena software is used to prove that the amount of output in a new layout can produce is higher than that the existing layout do. The proposal to create a new layout is to solve the original layout problem in the studied company. The alternative layout features proposed in this production section are based on:

- a) Maintaining the number of machines and equipment available
- b) The maximum distance for the renovation is 5 meters.
- c) The area of production area is the same as 27.5m x 86.8m.

At each stage of the original activities, areas, functions and positions of the plant are directly involved in the construction of rating charts based on ratings (A, E, I, O, U, X). The average output in the blanking section is between 500 pieces and 600 pieces of hard disk per operator for each shift. Expected output after layout improvement is 900 pieces of *hard disk* and above. In maintaining the number of machines and equipment available in the factory, the layout concept of Evans, 1997 was used in the planning of the new layout.

i- Identify each activity and list it on the contact chart.

a. Material flow analysis.

This stage is a synthesis of all the different process streams of functions and regions into new ones (Taho Yang, 2000). The number of lot sizes per week from one section to another will be included in Table 4.4. The table shows the number of lot sizes per week between a process and a related process.

iii. REL chart

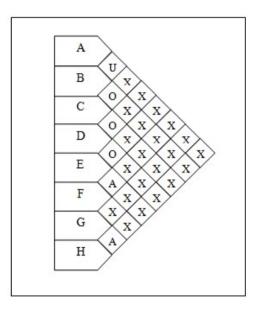


Figure 4.1. Relationship among area by using REL-chart

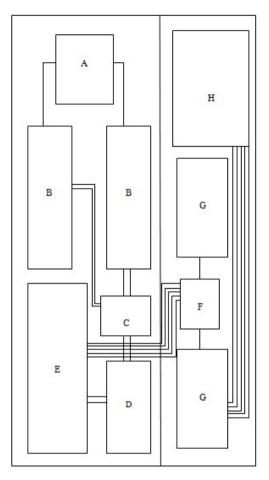


Figure 4.2. Layout overview using REL

Relationship chart shows the potential for good linkages between each region (Taho Yang, 2000). It facilitates potential needs at the pre-defined level and thus the choice of the interconnected space can be determined. This can be achieved by flow diagrams or relationship among one area function to other area functions as shown in Figure 4.1. The use of graphs through triangular grids links the intersections of one activity to another and determines the level of activity of each. Figure 4.2 is a layout illustration using REL chart.

4.5 Selection Layout

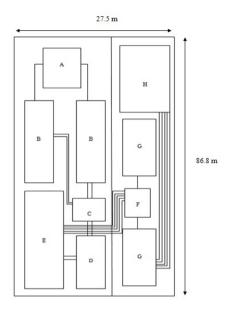


Figure 4.3. The actual layout of the factory.

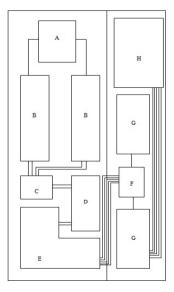


Figure 4.4. Alternative layout 1

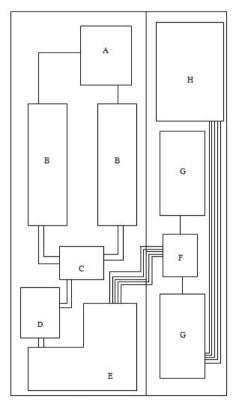


Figure 4.5. Alternative layout 2

Several new alternative layouts have been created without changing the actual size of the machine or equipment in the factory. The second alternative is chosen to propose a new layout based on the importance of one activity over another. Figure 4.3 shows the actual layout of the plant while Figures 4.4 and Figure 4.5 show the alternative layouts 1 and 2.

Figure 4.4 shows the first redesigned layout sketch without resizing the original machine or tool. The change is made by moving the positions between C, D and E machines as shown above based on the chart and their respective requirements.

Figure 4.5 shows the second alternative layout that has been made by changing the position of machine C, D and E. The second layout is an option in determining the best order of the study. This is because the position of machine E has been approached near the machine area F to shorten the movement of the operator from area E to F. The new arrangement further saves the movement time and thus shortens the overall cycle time in this blanking area.

Spacing changes play an important role in the value *expression* to be included in Arena software. Table 4.9 below shows the comparison of distances and *expressions* between the three layouts simulated using Arena software.

A 0.3 minutes value will be entered into the Arena software in the value section *expression*.

4.6 Simulation and Evaluation Using ARENA

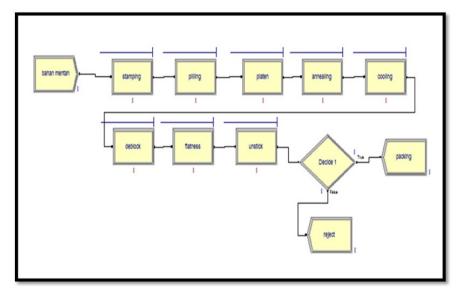


Figure 4.6. Computer hard disk production model

After selecting the desired layout, an evaluation using Arena software is performed to obtain data on the cycle times and outputs generated from the selected layouts. The entire process will be illustrated starting with modeling, simulation, visualization, and analysis. Figure 4.6 shows the hard disk production model according to the actual process flow. All evaluation data will be displayed at the end of the simulation.

4.6.1 ARENA simulation

ARENA simulation can provide data for analysis, description, and evaluation of the study performed. It also connects the level of communication and information within the organization. Figure 4.7 shows a complete summary of the simulation process in the existing layout. The amount of time and output of each layout can be determined and analyzed to allow for a comparison of his or her other two alternative arrangements.

The performance indicators shown in the figures above are important to show the total output and production costs involved in a given layout. The total output on the original layout is 600 pieces of *hard disk* per person per shift.

Figure 4.9 shows the simulation results in which all data entered is verified by the SIM decision. Replication time for input is 3.006 hours of operation per-coil *hard disk*. The overall results of SIMAN are important to support the authors' research to validate data entered such as number of hours worked, hours of operation and cost of work.

Based on the results on Table 4.10, the total number of products produced by the company *(blanking)* using the existing layout is 600 one piece per shift. There are three types of time listed in the table above, *expression, non value added* and wait time. The wait time in the process *annealing* is higher than the other process because it takes more than 7 hours for heating *hard disk*. Whereas for *cooling, De block, flatness* and *unstick processes,* no waiting time was recorded as the process network was continuous continuously. With the new layout, it is believed to reduce wait times while increasing output on each output.

4.6.3 Alternative layout results

The results in Table 4.11 show the differences between the three layouts simulated using Arena software. There is a significant difference between the expression values of the three layouts, *platen*, *annealing* and *cooling*. The differences in the input values are based on different distances for each layout. In addition, differences in values *expression* will also affect the output values to be generated. It can be seen that output is increasing in the second layout of 900 pieces per shift. This means that the shorter the time *expression* per process, the higher the output value can be generated. Table 4.11 shows the results through the arena analysis of the three tested layouts.

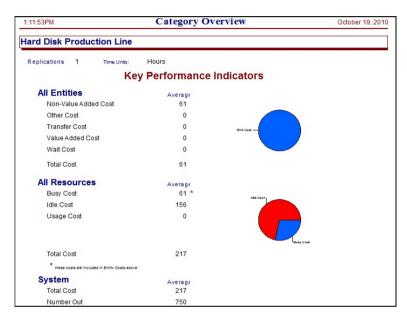
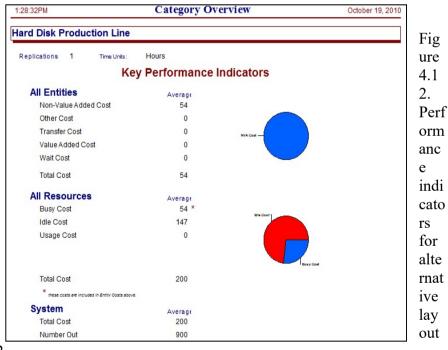


Figure 4.10. Performance indicators for alternative layouts 1

4.8 Suggestion

From the previous study, the proposal for a new layout to replace the old layout is a second alternative layout. This is based on the total cycle time obtained shorter than the other two layouts of 48.85 seconds per *hard disk* compared to 74.02 seconds for the original layout and 55.42 seconds for the first alternative layout. Although the cycle time differences between these three layouts are not significant, they do have a significant impact on the company to increase output and subsequently manage its operating time wisely. The output generated by the blanking part increased by 360,000 pieces from 720,000 pieces making the overall value of the second alternative layout a total of 1080,000 pieces of *hard disk* per month.

4.9 Conclusion

At the end of this chapter it can be concluded that by increasing the distance between one machine and another, the time taken especially the operator's time becomes shorter. Saving time will bring double benefits to the company as more output can be produced in less time. However, this study is one of the experiments and will be recommended to the industry depending on the acceptance of the studied company itself. This is because the company need to take into account the costs involved in creating a new layout.

CHAPTER V

CONCLUSIONS OF THE STUDY

5.1 Introduction

This chapter discusses the conclusions of the overall results of the study. The conclusions of this study are based on the objectives of the study which are to study the cycle time of computer *hard disk* production process, to study and understand the flow of each process, and to evaluate and simulate using systematic layout planning (SLP) and Arena software.

5.2 Final Conclusions

Total cycle time (*blanking process*) at the studied company is 74.02 seconds per *hard disk*. The involved time in finding the cycle time is processing time, check time, waiting time, and delivery time. The cycle time according to the second alternative layout selected was 48.85s. Reducing cycle time is a good starting point for improving production operations. On the other hand, the longer cycle time may result in higher production costs as well as poor production. Reducing cycle time helps management find the exact time each process requires. Once the time has been reduced for unnecessary activity, the actual time allocated to that activity can be identified. In addition, the application of SLP (systematic layout planning) introduced by Richard Muther was successfully implemented to produce two alternative layouts for the proposal to replace the original layout in the blanking section. There are 10 steps that have been implemented in the development of SLP, namely production activities, materials flow analysis, building charts, building the required space, building relationships between activities, identifying boundaries and boundaries, building alternative layouts and ultimately evaluating curves set it.

The use of Arena software is one of the evaluation methods to prove the comparison of data between the original layout and the selected alternative layout. As a result, the second alternative layout was chosen as the best solution to improve the existing layout in the section of *blanking*. A second alternative layout was proposed to the studied company as a new layout in order to reduce cycle time and to reduce *bottlenecks*, and as well to create a safe and a comfortable environment for employees.
