Muhammad Pantarmo 18930030, Murakhman Sayuti Enggok, Iswiyati Rahayu, **Pembinaan Administrasi Pemerintahan Desa Oleh Camat Mantewe Dikabupaten Tanah Bumbu.** Pemerintah kecamatan merupakan tingkat pemerintahan yang mempunyai peranan penting dalam pelaksanaan pelayanan terhadap masyarakat, hal ini yang kemudian menjadikan Camat sebagai ujung tombak dalam pelaksanaan tugas- tugas umum pemerintahan serta sebagian urusan otonomi yang dilimpahkan oleh Bupati/ Walikota untuk dilaksanakan dalam wilayah kecamatan. Peraturan Pemerintah Nomor. 17 Tahun 2018 Pasal 10 Tentang Kecamatan, pemerintah menugaskan camat sebagai kepala pemerintahan untuk melakukan pembinaan dalam penyelenggaraan pemerintahan desa. Salah satu bentuk pembinaan yang mesti dilakukan pemerintahan kecamatan adalah melakukan pembinaan administrasi pemerintahan desa, karena hal ini merupakan salah satu kegiatan yang menunjang untuk terlaksananya pemerintahan desa yang baik. Dari latar belakang diatas, Penulis menemukan masalah pokok diantaranya: *Pertama*, Bagaimana Pembinaan Administrasi Pemerintahan Desa Oleh Camat Mantewe di Kabupaten Tanah Bumbu ?, *Kedua*, Apa Hambatan Pembinaan Administrasi Pemerintahan Desa Oleh Camat Mantewe di Kabupaten Tanah Bumbu. Jenis penelitian yang digunakan dalam penulisan penelitian ini adalah penelitian hukum empiris atau *survey*, karena berorientasi pada Evaluasi Pelaksanaan Kebijakan Hiburan Umum di Kabupaten Tanah Bumbu. Hambatan yang dihadapi oleh pemerintah kecamatan Mantewe yaitu sumber daya manusia yang dimiliki perangkat desa yang belum memadai serta kemampuan yang belum sesuai dengan keahlian pada bidang pekerjaannya dan keterlambatan pemerintah desa dalam menyerahkan laporan pertanggungjawaban kepada kecamatan.

Government Regulation Number. 17 of 2018 Article 10 concerning Districts, the government assigns the camat as the head of government to provide guidance in the administration of village governance. One form of coaching that must be carried out by the sub-district government is to provide guidance for village government administrations, because this is one of the activities that support the implementation of good village governance. From the above background, the author finds the main problems including: First, How is the Development of Village Government Administration by the Head of Mantewe Sub-District in Mantewe Islands Regency? Second, What are the Barriers to Village Government Administration Development by Mantewe Sub-District Head in Mantewe Islands Regency. The type of research used in the writing of this research is empirical legal research or survey, because it is oriented to the evaluation of the implementation of public entertainment policies in the city of Pekanbaru. This type of research is qualitative research, where qualitative research is research procedures that produce descriptive data in the form of written or spoken words from people and observable behavior that is directed at the setting and the individual holistically (intact). From the results of research, guidance by the camat of village government officials in a sub-district is needed to achieve orderly village government administration and an effective government system. This is based on the indicators used in

this study, namely; Planning has been carried out optimally, guidance has been implemented. But it has not run optimally, the briefing has been carried out. But it hasn't run optimally yet, training has been carried out. However, it has not run optimally and Guidelines have been provided optimally. The obstacles faced by the Mantewe sub-district government are the inadequate human resources of the village apparatus and the abilities that are not in accordance with the expertise in their field of work and the delay of the village government in submitting accountability reports to the sub-district.
