EFFECTIVENESS OF JUMBLED LETTERS GAME TECHNIQUE FOR TEACHING VOCABULARY MASTERY AT SEVENTH GRADE OF SMP NEGERI 23 BANJARMASIN SCHOOL YEAR 2019/2020

Jumble Letters is a word puzzle with a clue, a drawing illustrating the clue, and a set of words, each of which is "jumbled" by scrambling its letters to make an anagram. A solver reconstructs the words, and then arranges letters at marked positions in the words to spell the answer phrase to the clue. The clue and illustration always provide hints about the answer phrase. Jumbled letters is a strategy used to unlock the difficulty of the lesson. The teacher will prepare pieces of the paper where in each piece one letter of the term to be defined. Game is a kind of activity which provides amusement condition and offers challenging. Besides it makes feeling proud for the participant who can win the game.

The objective of the research is to identify the effectiveness of Jumbled Letters Game Technique for teaching vocabulary mastery. The research used experimental.

To collect the data, the researcher used test. Test was done twice pretest and posttest. Pretest was done to know the students' achievement in teaching vocabulary mastery before giving treatment. Meanwhile, posttest was done to know the students' achievement in teaching vocabulary mastery.

The working hypothesis is tested in tis section states that the students who are taught vocabulary by using guessing game have better score on the posttest than on the pretest. The result of t-test perform on the data of students score in vocabulary comes to finding that t-value is 36,504 while the critical value of t at 5% of one tailed test is 2,064. It is indicates that the working hypothesis is accepted because the obtained t-value exceed the critical t-value.

Based on the finding, it is then concluded that Jumbled Letters Game Technique is effective in teaching vocabulary mastery.

ABSTRAK

They still feel difficult to use English Vocabulary in communicating so that the students don't have motivation in learning English.

Conclusion sig > 0,01 there is self difference between before and after counseling.

From the result of calculation, it is obtained the value of the T is 36,504 the degree of freedom (df) is 24 (obtained from N-1)=(25-1=24). The researcher used the degree of significance of 5% and 1%. In the table of significance, it can be seen the df 29 and the degree of significance are 2,064 and 2,797 . If compare with each value of the degree of significance, the result is 2,064 < 36,504 > 2,797. The result of analyzing the data by using the above formula shows that the coefficient is 36,504. It means that there is a significance increase after the using the real object for teaching vocabulary.

According to Sudjiono (2005:328) if the result of calculation t is higher that tt (t-table), t >tt; the null hypothesis (Ho) is rejected. If the result of calculation t is lower than tt (t-table), t < tt; the null hypothesis is accepted. Since the scores obtained from the result of calculating, the alternative hypothesis (Ha) is accepted and the null hypothesis (Ho) is rejected. In other word, the researcher hypothesis is accepted. It means that there is significant differences between students' achievement teaching vocabulary.

Based on the result of data analysis, Jumbled Letters Game gave significant effect to the Jumbled Letters Game technique for teaching vocabulary mastery at the seventh grade of SMP Negeri 23 Banjarmasin school year 2019/2020.

CLOSURE

Effectiveness of Jumbled Letters Game Technique for teaching vocabulary mastery. In this research, the researcher was done the experiment by using test, the test was pre-test and post-test. According to the result of students' pre-test and post-test in the seventh grade of SMP Negeri 23 Banjarmasin, the researcher found that the students who were taught vocabulary through Jumbled Letters Game technique got higher result than the students who were not taught vocabulary through Jumbled Letters Game.

The computing of t-test proves that the Ha is accepted. It can be seen by the score of t-test. The score of t-test is 36.504 and the t-table is 2,064. If the score of t-test higher than t-table (36.504 > 2.064), the alternative hypothesis can be stated that it is effective to use Jumbled Letters Game as a technique for teaching vocabulary among the seventh grade students of SMP Negeri 3 Banjarmasin.

The researcher concludes that teaching vocabulary using Jumbled Letters Game is more effective. It is because Jumbled Letters Game is more interesting. The use Jumbled Letters Game is one way to recognize and many remembering word during the teaching and learning process. But the ability to use the words they have to communicate depends on the individual. When they always improve their new words constantly, they will be able to mastery them and can be used in daily life gradually well.
